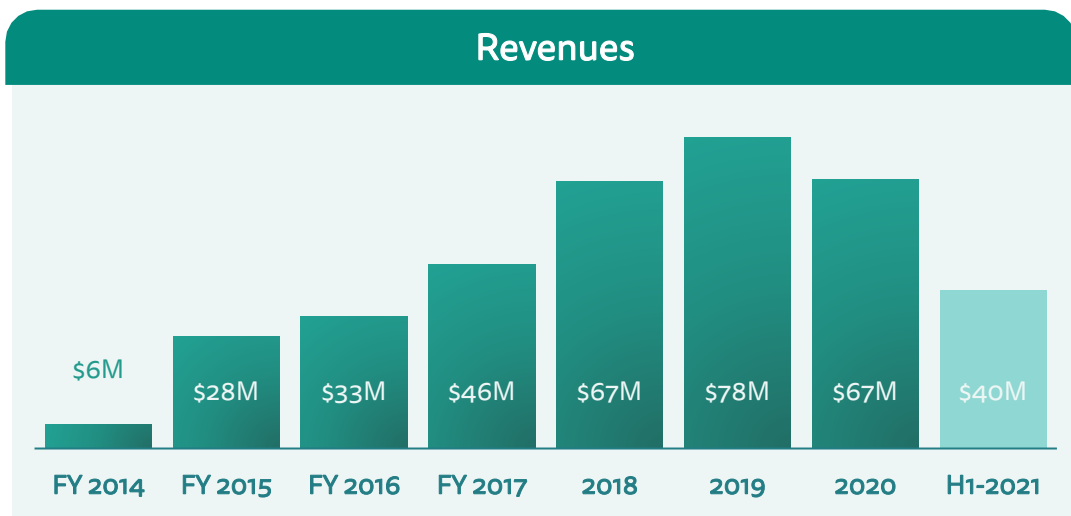

Altius directly and indirectly holds diversified royalties and streams which generate revenue from 13 operating mines. These producing royalties are located in Canada and Brazil and provide exposure to copper, zinc, nickel, cobalt, iron ore, potash and thermal (electrical) coal.

Altius also holds a large portfolio of exploration stage projects which it has generated for deal making with industry partners that results in newly created royalties and equity and minority interests. Altius also has a 59% interest in Altius Renewable Royalties Corp. (TSX:ARR), which holds royalties related to renewable energy projects. Altius is a member of both the S&P/TSX Small Cap and S&P/TSX Global Mining Indices.

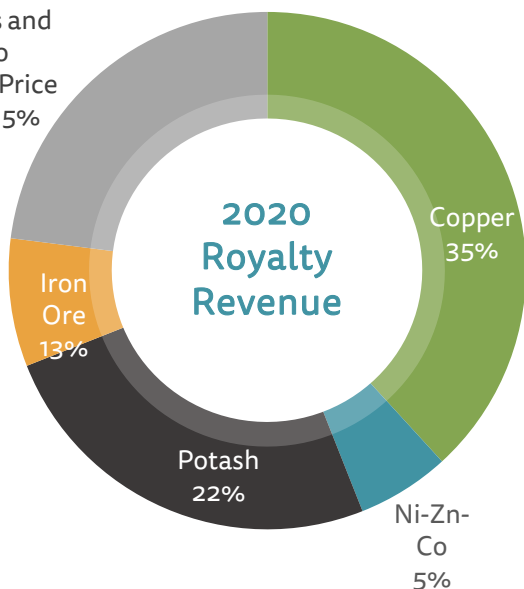
